With reference to your application on the subject cited above, I am directed to convey the permission of the Director of Education, Delhi to your society to establish a new school from class Ist to VIII without aid to Saket of the Bistrict South subject to the following conditions:-

- That the provision of DSEAR, 1973 and the rules framed thereunder shall be observed by the society.
- That the management of the school will fulfil all the conditions, laid down under Rule 50 and will provide all the facilities given in Rule 51 of DSER, 1973 to the institution,
- That the management of the school will get the scheme of management approved from the department immediately.
- That only qualified and trained teachers will be appointed 40 at prescribed Govt, scales alongwith all allowances will be paid to the teaching and non-teaching staff through
- That the management of the school will not ask for grant--in-aid from the department. 6.0
- That the school will not sun for the profit of any individual association or group of persons.
- That in case at any time the management of the school 70 is unable to run the school; moveable and non-moveable property of the school, will be transfered in the name of Director of Education, Delhi.
- That the management of the school will apply for grant 80 of recognition of the school under DSEA and Rules, 1973 separately and recognition will not be granted unless statutory, provision of Sec. 4(i) (a) to (f) read with

- That all the recognised classes shall be run at one
- That the management of the school will obtain more land 100 from the DDA in the name of the society through Directorate of Education, Delhi. For running middle school and middle classes be shifted to the new site with the permission ij.
- That the school shall be run under the management of Saba Educational Society (Regd.), C/o Vidya. Niketan, D-Block, Saket, New Delhi and suitable funds will be made available for the construction of suitable building on the land allotted to the society, as declared as per the specification of the department within a period of 3 years and adequate and sufficient accommedation of 12 sq. ft. per student shall be provided for class-room. The normal size of the class room is 24 % X 20 % No other activities other than education shall be run.

If recognition for the existing school is not sought after fulfilling all the above conditions within a period of 3 years, this permission to run a new sch ol shall be treated
